3. Specifications

3.1.Intended Use

magLEAD 12gC employs PSS's original Magtration® technology to perform automated isolation and purification of nucleic acids (DNA, RNA) from biological samples using magnetic particles as preparation for in vitro diagnostic testing using genes.

magLEAD 12gC is intended to be used only in combination with the MagDEA Dx reagent kits for this instrument only for the applications described in the product's instructions for use. The system is intended for use by professional users, such as technicians and physicians trained in molecular biological techniques and the operation of the magLEAD 12gC.

4.System Components 4.1. Front View




*1: Green LED: Lit when powered on

4.2. Side and Rear View

The power switch is located on the left side of the instrument. The fuse box and connectors are located on the back of the instrument.




Note

 Replacement of the fuse shall only be made by field service personnel authorized by PSS. Contact us for fuse replacement.

4.3.Internal Components

The Magtration® unit and stage unit are located inside the instrument.



1. Magtration[®] Unit

- Syringe Unit: Twelve nozzles for simultaneous processing of up to 12 samples with accurate and rapid aspiration and dispensing.
- Magnets: Twelve magnets aligned with 12 tips for simultaneous separation of magnetic particles from up to 12 samples.

2. Stage Unit

- Reagent Cartridges: Simple placement of special disposable cartridges pre-filled with reagents minimizes cross-contamination.

 The back two positions (wells) in the cartridge are used for heating.
- ➤ Tip Sets: Positions for tips (DN100N tips) in the tip sheath. One or two tips or tip sheath (Sheath DN100) are used per sample depending on the protocol. Refer the instructions provided in the package insert for the reagent kit.
- > Elution Tubes: Positions for Micro tube.
- Sample Tubes: Positions for Micro tube.

5.Installation

5.1. Setup procedure

1. Remove the instrument from the shipping crate.



Warning

- The instrument will be installed by field service personnel authorized by PSS. Contact us if you need to move the instrument.
 - 2. Remove the protective films attached to the instrument.
 - 3. Open the instrument door.




4. Push the pipettor head upward.




5. Remove the bubble wrap, Y-axis fixing bracket, and silica gel bag.







6. Connect the power cable and the handheld barcode reader that came with the instrument. Connect the power cable to the wall outlet.






Caution

 Do not use any power cable other than the one provided to avoid risk of fire or temporary blackout.

7. Confirm that the power switch is turned off. Following the images below, open the inlet cover and insert the IC Card. Make sure that the picture side is on the left and the triangle mark ∇ faces down when inserting the card. After inserting the card, turn on the power using the switch on the left side of the unit.



Removing IC Card

Before removing the IC card, make sure that the power is switched off. Press the bottom as shown below and pull out the card.







Caution

- Ensure that the power is turned OFF when inserting or removing the IC card. The card and/or the instrument may become damaged if the card is inserted or removed while the power is on.
- Handle the IC Card with care as it can be damaged by impact, exposure to water or dust
- If the IC Card is not inserted properly, the LCD may not display correctly. Ensure that the IC Card is inserted properly.
 - 8. Make sure that the instrument completes the homing operation of all axes after it is powered on.
 - 9. Installation is complete.



Caution

• When transporting the instrument, be sure to fix the syringe unit and stage using cushions and screws to avoid any damage to the instrument.

5.2. Configuration and setting up the instrument

5.2.1. Setting the installation date

The first time the magLEAD 12gC is switched on, the installation date must be entered. This date will be recorded in the report file described below.

In addition, the instrument uses this installation date for determining when to display the weekly and annual maintenance reminders.

SERV: SETUP SYSTEM Installation date DD MM YYYY

Key: Up, Dn, SHIFT, ENT

Set the day, month, and year. Press "SHIFT" and the down arrow to move the cursor to the right, from DD (day) to MM (month) to YYYY (year).

Press "SHIFT" and the up arrow to move the cursor to the left, from YYYY to MM to DD.

Press the up arrow or down arrow to increase or decrease the value of the selected field.

After setting the date, store the setting by pressing "ENT".

Press "ESC" to leave the date unchanged.

If you accidentally set the wrong date, call Precision System Science.

5.2.2.Setting the serial port

Set the serial port to use a PC as the output device for the report file (Section 5.2, 11, 12).

5.2.3.Setting time and date

The magLEAD 12gC has an integrated clock and date tracker.

Check the time and date and reset if necessary.

(Section 9.3.1 and 9.3.2)

5.2.4.Setting the preventive maintenance reminder

The magLEAD 12gC reminds you when the annual maintenance is due. You can set the reminder to alert you annually or semiannually. (Section 9.3.4).

5.2.5.Installing the barcode reader (optional)

The barcode reader is powered through the data cable.

Unpack the barcode reader. Connect the cable to the barcode reader.



Connect the barcode data cable to the instrument. The connector is located at the rear of the instrument, labeled "Barcode Reader". Make sure that the connector is secured with the two screws provided. Switch on the magLEAD 12gC instrument.

The data communication between the barcode reader and the instrument uses a RS232 interface.

5.3.Installing the PC software (optional)

The magLEAD 12gC software "magLEAD Communicator" must be installed on the PC.

This software is required for receiving report files from instrument and storing instrument data on the PC hard disk.

5.3.1.System requirements

- Operating system: Windows 10, Windows 7 or Windows 8
- USB-Port: USB 1.1 or higher
- Microsoft.NET Framework V1.1 (freely available for download at www.microsoft.com) installed on the PC

The instructions in Sections 5.3.2 and 5.3.3 refer to the Windows 10 operating system.

Specifications for Windows 8 are similar, but the appearance and some parameters may vary.


5.3.2.Installing the driver of the USB-RS232 converter

Installing the driver


If the PC has no RS232 port, first install the driver of the USB–RS232 converter on the PC. For detailed installation procedures, refer to the manual for the USB-RS232 converter. Insert the CD and follow the instructions.

5.3.3. Mapping the COM port (For users of "Windows 10 Professional")

- Right-click on the Windows button to open the "Device Manager".
 NOTE: The way to open the "Device Manager" differs depending on the OS you are using.
- Open the "Device Manager". NOTE: The process to open the Device Manager varies according to the operating system version.
- Expand "Ports" to show all available COM ports.
- Connect the converter to an open USB port on the PC.
 The device manager should then automatically update the COM port list.
 Look for the COM port named "USB Serial Port".



- Right-click this COM port and select "Properties".
- Click the "Port Setting" tab and select the "Advanced" button.



■ Change the dialog field "COM Port Number" to "COM1". The USB port is now mapped to COM port 1. Always use COM Port 1 when working with the magLEAD 12gC.


5.3.4.Installing the magLEAD Communicator

- Insert the CD labeled "magLEAD Communicator" into the PC. Start "Setup.exe".
- The installation wizard will guide you through the installation process.
- After installation, open the magLEAD Communicator by double-clicking the magLEAD Communicator icon in the lower system bar.



The user interface of the "magLEAD Communicator" opens.

■ Select "Options" and open the "Serial port" window. Check the "COM1" box.




- $\hfill \blacksquare$ The magLEAD Communicator is now ready to receive data from the instrument.





7. Directions for Use

7.1. Door operation

The door moves up to open and down to close. It is held by magnets at both the top and the bottom.

When opening or closing the door, be careful not to pinch your hand or fingers and be sure that the door is held in place by the magnets at the top or the bottom.


Caution

• The door may slide downward if it is not held by the magnet at the top. When opening the door, make sure lift the door fully that you hear a clicking sound at the upper end.

7.2. Inserting Reagent Cartridges into the Reagent Cartridge Rack

1. Hold the bar code side of the reagent cartridge as shown in the figure below. Slide the cartridge diagonally upward into the rack and slide it along the groove until it hits the stopper at the far end.





2. Place the reagent cartridge rack into the rack position on the stage.

Reference

Be sure that two farthest wells of the cartridge fit into the heating block.







Caution

 Operating the instrument operation with the Reagent Cartridges or the Reagent Cartridge Rack incorrectly positioned may result in instrument malfunction.

7.3. Inserting Sample Tubes

Place Micro tubes (without caps) containing the samples into the Tip/Tube Rack.



7.4. Inserting magLEAD Tip and Sheath sets

magLEAD Tip and Sheath set insert them into the holes of the Tip/Tube Rack.



7.5.Inserting Elution Tubes

Place the Micro tubes (for elution) into the Tip/Tube Rack.





7.6. Inserting the Tip/Tube Rack

Place the tip/tube rack into the instrument. Refer to the pictures below for the placement direction of the rack. Please make sure that the tip/tube rack is correctly aligned with the location pins.



Insert the rack, making sure that the holes on the right side of the rack fit to the location pins on the stage.







Caution

• Operating the instrument with incorrectly positioned Tip Sets or Tip/Tube Rack may result in instrument malfunction.

Note

When running a protocol with a small number of samples, use bilaterally symmetric positions in the Reagent Cartridge Rack and the Tip/Tube Rack, using central positions with high priority.

8.2. Startup and Shutdown Procedure

8.2.1. Startup

- 1. Make sure the instrument is turned OFF. Insert the IC Card into the IC card inlet, ensuring that the card is in the correct orientation.
- 2. Turn on the instrument using the power switch on the left side of the instrument.
- 3. As shown below, the "Power On Screen" screen will appear on the display. All axes will be homed automatically during the system initialization.

The efficiency of inactivation must be determined for each specific organism and depends on the layer thickness and sample type. Precision System Science cannot guarantee complete eradication of specific pathogens.

12.magLEAD Communicator (optional)

magLEAD Communicator is a software program that runs on a PC.

The software receives the report file (refer to section 11) and stores it in a folder defined by the user.

After the PC has received the report file, you can use and process the file with a LIMS (Laboratory Information Management System) or other programs.

12.1.User interface


The main window shows the list of report files received.




The report file name contains the following components:





13.2. D-Ring Maintenance

To ensure complete connection and to prevent leakage, we recommend performing maintenance of the D-Rings once every two weeks.


1. Wearing gloves, wipe away old grease using a paper or cloth.



2. Slightly apply some silicon grease to your gloved finger.



3. Wipe the silicon grease onto the surfaces of the D-Rings (black rubber rings on the nozzles).



4. Wipe off any excess silicon grease from the edges of nozzles and the tip ejector using lint-free paper.



Caution

 Excess silicon grease can lead to instrument operation problems, such as improper tip removal.

14.Troubleshooting 14.1. Error Reported During Protocol Run

- 1. If an error occurs during a protocol run, the above screen will be displayed. The red alarm LED will blink, an audible alarm will sound, and the instrument will stop operating.
- The error code is displayed in the second line as "Code: XXX". Refer to the error code list, and take appropriate action as recommended.
 Take note of the error code, because you will need to provide it when contacting us for technical support.



Caution

- "LineNo.= ####" indicates the line number of the protocol where the error occurred.
- A protocol run that was interrupted by an error cannot be resumed.
- 3. Press the "ESC" key after confirming the error to display the MENU Screen.
- 4. Press the "1" key in the MENU Screen to display the Manual Screen.
- 5. Press the "2" key in the Manual Screen to return the tips to the tip holders and to home all axes.

It is possible to stop a protocol run while the run is in the data reading phase before <u>extraction phase</u> (e.g., sample tube barcode information). Follow the instructions below.

1. Press "STOP". The following screen appears:

===== PAUSE ===== START:Continue STOP: Stop Key:START, STOP

2. Press "STOP" again to abort the protocol, or press "START" to continue the protocol.

It is possible to abort a protocol run while the instrument is actively processing samples. Follow the instructions below.

1. Press "STOP". The following screen appears:

Do you really want to abort the run ? Key:START, STOP

Note that the protocol has not stopped yet.

2. Press "STOP" again to abort the protocol.

The protocol run will be invalid and will be marked accordingly in the report file. The following screen appears:

DD MM YYYY HH:MM START:Run 1:UV 2:Man 3:Test 4:Setup Key:START, 1, 2, 3, 4

Alternatively, if you do not want to abort the protocol at this point, press the "START" key.

The protocol run will not be stopped and should not be affected.

3. After aborting a protocol, press "2" to display "Manual" in the display.

Press "2" again to return the tips to the tip rack and to return the modules to their home positions.



Caution

- If the instrument stops while there are tips on the nozzles, follow the steps described above.
- Keep the door closed while operating the instrument. Re-check that disposables have been positioned correctly.
